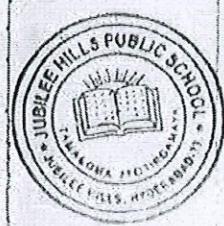
I request the Government to forward the proposals to C.B.S.E., New Delhi alongwith the No Objection Certificate of the State Department subject to the following conditions:-

I wish to submit that the Dist. Educational Officer, Hyderabad vide his letter cited has submitted the proposal for the issue of No objection certificate for affiliation to C.M.S.E., New Delhi alongwith a report of the Deputy District Officer, Rajahmundry wherein he has justified the need to establish the school with affiliation C.M.S.E. in the area and recommended the proposal.

In view of the above, I submit herewith the proposal with a request to issue No objection certificate for affiliation to the C.M.S.E., New Delhi of Jubilee Hills Public School, Hyderabad subject to fulfillment of the following conditions:

1. Untrained and unqualified staff should not be recruited.
2. The staff should not be replaced frequently unless warranted.
3. All the staff should be paid salaries as per pay scales of pay with usual allowances.
4. Fees should be collected at the rates not higher than those prescribed by State Government/C.M.S.E., New Delhi.
5. The State Government shall have the authority to withdraw the No objection certificate if its Management violates any of the Departmental rules.
6. The State Government Departmental officers shall have the authority to inspect/visit the school.
